This MoU between two colleges affiliated to Shivaji University, Kolhapur is made on Monday, 29<sup>th</sup> Aug.2022 for a period of five years from 2022-23 to 2026-27.

The said MoU is a platform for student exchange and faculty exchange for academic purposes by the departments of English of the respective colleges. The purpose behind this enterprise is to bring about enrichment of UG and PG level students in terms of knowledge and skills.

The two colleges shall hereinafter be referred to collectively as 'Parties'.

# Objectives

- To strive for enrichment of student's knowledge in the subject of English language and literature
- To enhance English communication skills
- To undertake faculty exchange and student exchange for academic purposes
- To provide exposure to experts in the field
- · To develop creative and critical thinking abilities
- To inculcate values embodied in literary works
- To help the students to face NET/SET and other Competitive Examinations

#### Outcomes

After the implementation of the programmes, the UG and PG students of the said colleges will be able to

- Understand the subject better and more comprehensively
- Develop advanced English communication skills- Speaking and Writing
- Enrich referencing skills and
- Acquire self-learning skills- creative and critical thinking
- Imbibe values and developcultured outlook
- Face NET/SET and other examinations successfully

## Activities to be conducted under MoU

- 1. Student exchange
- 2. Faculty exchange
- 3. Guest Lectures/Workshops/Training programmes
- 4. Visit to libraries/language labs
- 5. Academic competitions

#### TERMS OF AGREEMENT

The Parties shall be conducting activities as given below.

- Academic calendar of activities shall be prepared every year in consultation with all the parties.
- 2. Each Party shall host at least one programme/activity during an academic year. The host Party shall bear the expenses for the same. If a Party is unable to do the same for some reason during an academic year, the same shall be rescheduled in the subsequent year.
- 3. Each Party shall depute at least one faculty as part of Faculty Exchange Programme to at least one programme during an academic year, failing which the same shall be undertaken

- during the subsequent year. The expenses for this shall be borne by the same Party deputing the faculty.
- 4. Other Parties shall depute their students to the host party for the programmes to be held during the academic year. The parties concerned shall bear transportation expenses of their students and faculty (if any).
- Visit to the library/language lab of the host college may be organized after the academic event.
- Academic competitions of various types for students shall be organized for the purpose of assessing attainment of outcomes.
- The time, date and duration of the programmes, choice of topics/content and such related matters shall be decided by mutual consent and convenience of all the parties concerned.
- 8. The programmes shall be scheduled keeping in view students' academic schedule.
- The host party shall provide the required infrastructure, i.e. classroom/s, LCD projector, internet connectivity and such other facilities for the duration of the programme.
- 10. All the Parties shall designate a faculty, preferably the Head, Department of English, as Coordinator who will be authorized to communicate and finalize the activities to be conducted during the period of MoU.
- 11. The term of contract shall remain in force for the period of three years from the date of signing of the Agreement unless extended on mutual agreement.
- 12. Termination of Agreement could be done by any Party after giving notice to the other Parties one month in advance.
