Memorandum of Understanding

Memorandum of Understanding on Academic Cooperation between Dattajirao Kadam Arts, Science and Commerce College, Ichalkaranji affiliated to Shivaji University, Kolhapur and NN Soft Solution recognizing the benefits to their respective college/institute from the

establishment of academic collaboration, conclude this Memorandum of Understanding (hereinafter: "MoU").

1. The purpose of this MoU is to develop academic and educational co-operation and to promote mutual academic understanding between the two parties.
2. Each party agrees to develop the following collaborative activities in the academic areas of mutual interest, on the basis of equality and reciprocity.
 - a) Exchange intellectual understanding
 - b) Exchange of research ideas
 - c) Conducting lectures and organizing public event
 - d) Conducting research activities
3. The development and implementation of specific activities based on this MoU will be agreed between both institutions, which carry out the specific projects. Each Party agrees to carry out these activities in accordance with the policies and regulations of the respective colleges after full consultation and approval.
4. It is understood that the implementation of any of the types of cooperation stated in Clause shall depend upon the availability of resources of the Parties concerned.
5. Both Parties agree that prior written approval is required before using the other Party's name, Logo or other Intellectual Property rights in any advertising or associated publicity.
6. Should the collaborative research activities under this MoU result in any potential for Intellectual property, each Party shall seek an equitable and fair agreement as to ownership and other property interests that may arise.
7. This MoU may only be amended or modified by a written agreement signed by the Representatives of each Party.
8. This MoU is valid for a period of Five years from the date of signing by the authorized signatories of each Party. Each Party shall review the status of the MoU at least three months before the end of the three-year period to determine whether it wishes the MoU to continue and if so, any modifications that might be necessary. The period of validity of this MoU may only be extended by the mutual written consent of both Parties.
9. This MoU may, at any time during its period of validity, be terminated by one of the Parties upon prior notice to the other in writing not later than six months before the termination date.
10. The Parties may disclose certain confidential information to the other in relation to any future.

Proposal made under this MoU, Each Party therefore agrees that the contents of this MoU and the negotiations in relation to any future proposal remain strictly confidential and each Party hereby undertakes not to disclose the same to any third Party, save for its professional advisers, Without the prior written consent of the other Party except where such disclosure is required by law (Including, without limitation, under applicable freedom of information legislation).
